TERMS AND CONDITIONS OF RENTAL CONTRACT- PENNDEL EQUIPMENT RENTAL LLC

For good and valuable consideration, you and PennDel Equipment Rental LLC, a Pennsylvania limited liability company, (also referred to herein as "Penn", "Lessor," "we", "us" and "our") agree as follows: 1. <u>Definitions</u>: As used herein, "P.1" refers to the first page or "face" of this Contract; "Contract" refers to P.1 together with these Terms and Conditions, "Rented Item(s)" or "Item(s)" means the item(s) rented to you, as identified on P.1; "Site" means the address set forth on P.1 where the Item(s) is/are to be delivered and/or used; and "Customer," "Lessee," you" and "your" mean the "Renter," "Customer," "Lessee" and/or "Guarantor" (as applicable) identified on P.1.

2. <u>Term</u>: You agree to rent from Penn the Rented Item(s) for the period(s) specified on P.1 (the "Term"), to get us our stated rental rate(s) (the "Rent"), together with all other charges accruing hereunder, without proration, reduction or setoff, and to remain liable for all injuries and damages arising from or associated with proration, reduction or setoff, and to remain liable for all injuries and damages arising from or associated with such Item(s), until all Rented Item(s) is/are returned to <u>and accepted by</u> Penn in the return condition required under this Contract (including § 7). Unless otherwise specifically agreed by Penn, all rental rates are for normal use of the Rented Item(s) on a <u>single-shift</u> basis during the Term, not exceeding 8 hours <u>per 24-hour period for</u> <u>which Rent is charged hereunder (each, a "Rental Dav"</u>, 40 hours per 7-Rental Day period, 160 hours per month (zero hours for any and all uncharged-for periods), and otherwise in accordance with the terms of this Contract. Additional Rent at our highest incremental rate will be charged for late returns and overuse. You will not be entitled to any cancellation right or reduction of Rent or other amounts coming due hereunder for time in transit, Act(s) of God, event(s) of force majeure or any other period(s) of nonuse. We have estimated the Rent based on your estimate of the length of the Term (the "Estimated Rent"). Unless otherwise agreed by Penn in writing, you agree: (a) to pay us: (i) the Estimated Rent specified on P.1 in advance of the Term (the "Prepayment"); and (ii) all other amounts coming due hereunder upon demand; and (b) that: (i) we may deduct any amount you owe us from any Prepayment; (ii) no interest will accrue on any Prepayment, (iii) no Prepayment will be deemed a limit of your liability to us; and (iv) all Prepayments are <u>NON-REFUNDABLE</u>. Anything remaining with, in or on any Rented Item(s) upon return will, at our option, be deemed abandoned. 3. You <u>SHALL NOT</u>: (a) permit the taking or existence of any lien, claim, security interest or encumbrance on any Rented Item(s); (b) have any title or ownership interest in or with respect to any Rented Item(s); or (c) <u>loan, share, transfer</u>, without our prior writter or ownership interest in or with respect to any Rented Item(s); or (c) <u>loan, share, transfer</u>, without our prior writter with a security interest or encumbrance on any Rented Item(s); or the secure of the sublease, store, surrender or assign any Rented Item(s) or this Contract, without our prior written consent (in our sole discretion). Penn may, from time to time, substitute Rented Item(s) and/or sell or assign all or any part of its interests in one or more Rented Item(s) and/or this Contract, in which event, you will attorn to

We will not be responsible for delay(s) caused by any acts or omissions of/by you, your agents, employees or contractors, or any other parties, including providers of other equipment or services ("Other Providers") for which you agree to indemnify, defend, and hold harmless Penn, its agents, employees, and contractors. If you are not present upon the provision thereof, you agree to accept the statements of our agents and representatives regarding the same (including status, condition, quality, utility, defects, and quantities of or with respect to, the Item(s) and the Site).

The foregoing remedies are EXCLUSIVE. Neither Penn, nor any TPO, shall have any other obligation(s) regarding Malfunctions, all of which you hereby waive.

Return Condition: You will ensure the Site is reasonably clean, safe, secure and fit for delivery and use of the Item(s), protect, properly maintain and care for each Item at all times, keep each Item safely and securely stored and locked when not in use, and return each Item to Penn on time at the end of the Term, complete, clean and free of contamination (including asbestos, beryllium, silica and pathogens), and otherwise in good order, condition and repair, properly serviced and maintained, and if applicable, fully charged and/or full of the appropriate fuel, fluids and lubricants. If you fail to do so, in addition to any other amounts specified on P.1, you apployate toe, industant and inclustants. If you had to be so, in addition to any outer allocations specified of P-1, you will promptly pay to Penn: (a) Rent at our highest incremental rate(s) until all such Item(s) have been returned or replaced as required; and (b) all costs and expenses we may incur in connection with such failure. You shall not, nor shall you permit anyone else to: (i) use any Rented Item while under the influence of any intoxicant(s) (including without limitation, CANNABIS, CANNABINOIDS, AND ALCOHOL, WHETHER OR NOT LEGAL) or to abuse, misuse, overuse, conceal, store with any third party, repair, modify or damage any Rented Item(s); (ii) violate any Instruction, insurance policy or warranty; (iii) expose any Rented Item(s) to any flammable, explosive, partful or hazardous substance(s). harmful or hazardous substance(s) or circumstance(s); (iv) disable, misuse or circumvent any safety equipment or device(s) in, on or with any Rented Item(s); or (v) take possession of or exercise control over any Rented Item(s), without our prior consent (in our sole and absolute discretion).
